The CHS Council Bluffs Pipeline and the CHS Conway Pipelines, are inter-regional petroleum pipelines solely owned by CHS who distributes products manufactured by a refinery located in McPherson, Kansas.

CHS operates this 85,000 barrel per day refinery and a 228 mile refined products pipeline from the refinery to Council Bluffs, IA where the storage terminal is located. Also there are 5 five distinct lines that transport various refined products to and from the refinery and underground storage caverns in Conway, KS. These five lines carry gasoline, NGL's, butane, propane and pentane.

In addition to the refinery and products pipeline, CHS's facilities include a regional office at McPherson and a crude oil trucking fleet of approximately 80 transports which operate in western Kansas. CHS also owns 100% of Jayhawk Pipeline, L.L.C., 66% of Kaw Pipe Line Company and 50% of Osage Pipe Line L.L.C.
